With increasing regulatory requirements and the complexity of managing such vast amounts of data, BGSD recognized the need to adopt a more proactive approach to data governance and compliance.

As staff transitioned or retired, a significant volume of data remained unaddressed, contributing to operational inefficiencies and posing a risk to compliance with data privacy regulations. BGSD needed to ensure that data was appropriately stored, managed, and disposed of in alignment with provincial data privacy laws.

### The Challenge

BGSD faced a multifaceted challenge in managing and protecting its extensive data landscape. The division's data environment included sensitive personal data of students and staff, much of which was duplicated across the network. Over time, the lack of proper management led to the accumulation of redundant and obsolete information, creating operational inefficiencies and exposing the division to compliance risks.

Data privacy became a growing concern, as teachers occasionally stored student records in personal drives rather than the designated provincial database, heightening the risk of a data breach. Complying with stringent provincial data privacy laws was critical, but BGSD needed a more robust system to manage these issues effectively.
